What is this thing called Digital Preservation (DP)..

- Digital Preservation:
 - "...all of the actions required to maintain access to digital materials beyond the limits of media failure or technological change."

[Preservation Management of Digital Materials: A Handbook, 2001.]

"...combines policies, strategies and actions that ensure access to information in digital formats over time."

Lest we forget...

- The key aims of digital preservation:
 - Keeping digital assets for as long as they are needed
 - Making sure they can still be accessed, regardless of inevitable changes in hardware and software
 - The assets remain an accurate rendering of authenticated content over time



What is this thing called Preservation Planning (PP)...

Planning:

"The purpose of planning is to establish credible plans for undertaking the required initiative, programme, or project, and to underpin other managerial activities, including the dissemination of planning information to stakeholders and other interested parties.

Effective planning is of vital importance and a prerequisite for the effective achievement of any programme, project, change or event."

[OGC - PRINCE2 Definition viewed 07/08]

"decide on and arrange in advance or make preparations for"

What is this thing called PP....

Preservation Planning - an OAIS functional entity:

"provides the services and functions for monitoring the environment of the OAIS and providing recommendations to ensure that the information stored in the OAIS remains accessible to the Designated User Community over the long term, even if the original computing environment becomes obsolete"


"preservation planning is perhaps the core OAIS function."

PP in OAIS model...

- Divided into 4 functions:
 - Monitor designated community
 - Monitor technology
 - Develop preservation strategy and standards
 - Develop packaging designs and migration plans
- OAIS does not show you how
 - You have to join the dots




Why Do We Need PP?

- DP can engender decision paralysis:
 - organisational/cultural
 - technical
 - resource
 - external/internal drivers on all the above
- There are choices:
 - Strategies to adopt
 - migration
 - emulation
 - technology preservation
 - Tools to support your chosen strategy:
 - PRONOM, DROID, JHOVE etc. etc.



Why Do We Need PP?

- The growing web of choices a maturing landscape
- PP makes dp more digestible by reducing it into byte size nuggets
- It is a logical next step from dp policies & strategies

Why Do You Need PP?

- How many of you have wrestled with:
 - Which strategy will best support my collection?
 - Does one strategy fit all?
 - What will the impact of my choices be?
 - How will these change with time?
 - How can I manage risk for a chosen strategy/collection?
 - Etc, etc



What Does a PP Help You to Do?

- The 'Independent Free Republic of DP' does not exist
- Need to contextualise
- PP is a managed process which addresses each of the components in a functional way
- Some of which are....



What does a PP Help You to Do?

- It supports decision making
- Helps you to blend your dp strategy in with other organisational policies and strategies
- To make sense to non domain experts e.g. budget holders, stakeholders, users etc.
- Provides a transparent audit trail of decisions etc



What does a PP Help You to Do?

- Defines workflows/methodologies e.g. risk assessment
- Find out what you've got, what you need to do and....
-provides triggers for when to do it
- Articulate roles and responsibilities
- Develop sustainable repeatable processes



From Dystopia to Order...

- PP facilitates a flexible approach which accommodates:
 - collection profile change
 - strategic priorities change
 - resource changes
- Outcome is an achievable solution to a particular set of circumstances
- Heisenberg 's Uncertainty Newtonian Order



Key message is...

(successful) Preservation planning is:

an organisational driven decision making process

NOT

a technology driven solution
