What Does IPR for Digital Preservation Look Like Today?

- Copyright, Designs & Patents Act 1988 s.37-44A
- Not fit for Digital Age
- Cannot preserve all categories of works and, as a result, works continue to deteriorate

UK Developments

- Hargreaves Review report published 18 May 2011
- <http://www.ipo.gov.uk/ipreview.htm>
- Extension of preservation copying by archives and libraries to cover all works
- Provision on orphan works
- Government broadly accept recommendations

Extension of Preservation Copying

- Government to bring forward proposals for opening up copyright exceptions regime Autumn 2011
- Widen exception for copying by libraries and archives to all cover all works
- Enable preservation of content through digitisation

Orphan Works

- Hargreaves revived orphan works provisions in Clause 43 Digital Economy Bill
- Legislate to permit access to orphan works where owner not identifiable – allow commercial and cultural uses
- Establish extended collective licensing for mass licensing of orphan works and clearance procedure for individual works
- Government to bring forward proposals autumn 2011

Developments in Europe

- EU Draft Directive on Orphan Works 2011/0136 (COD)
- System of mutual recognition of orphan status of a work to facilitate cross border digitisation and dissemination of works
- Libraries, educational establishments, archives
- Use orphan works to further public interest missions, notably preservation, restoration and the provision of cultural and educational access to works contained in their collections

What will IPR for Digital Preservation Look Like in 2015?

- Archives and libraries will be able to copy all categories of copyright works for preservation
- Mass digitisation of orphan works possible
- What reuse rights?
