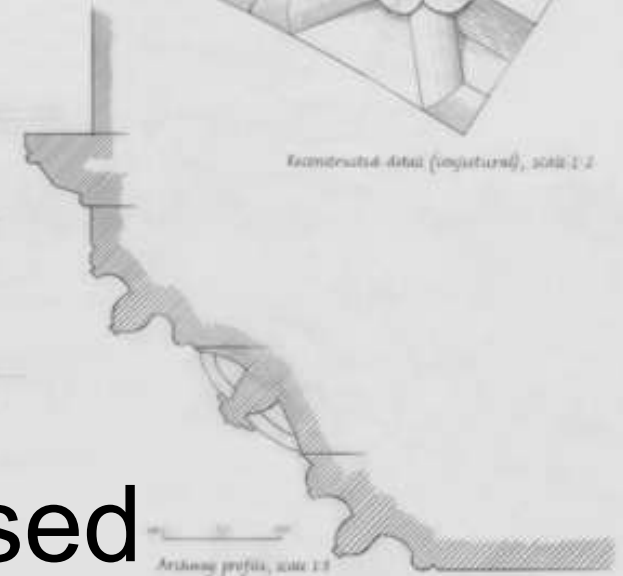

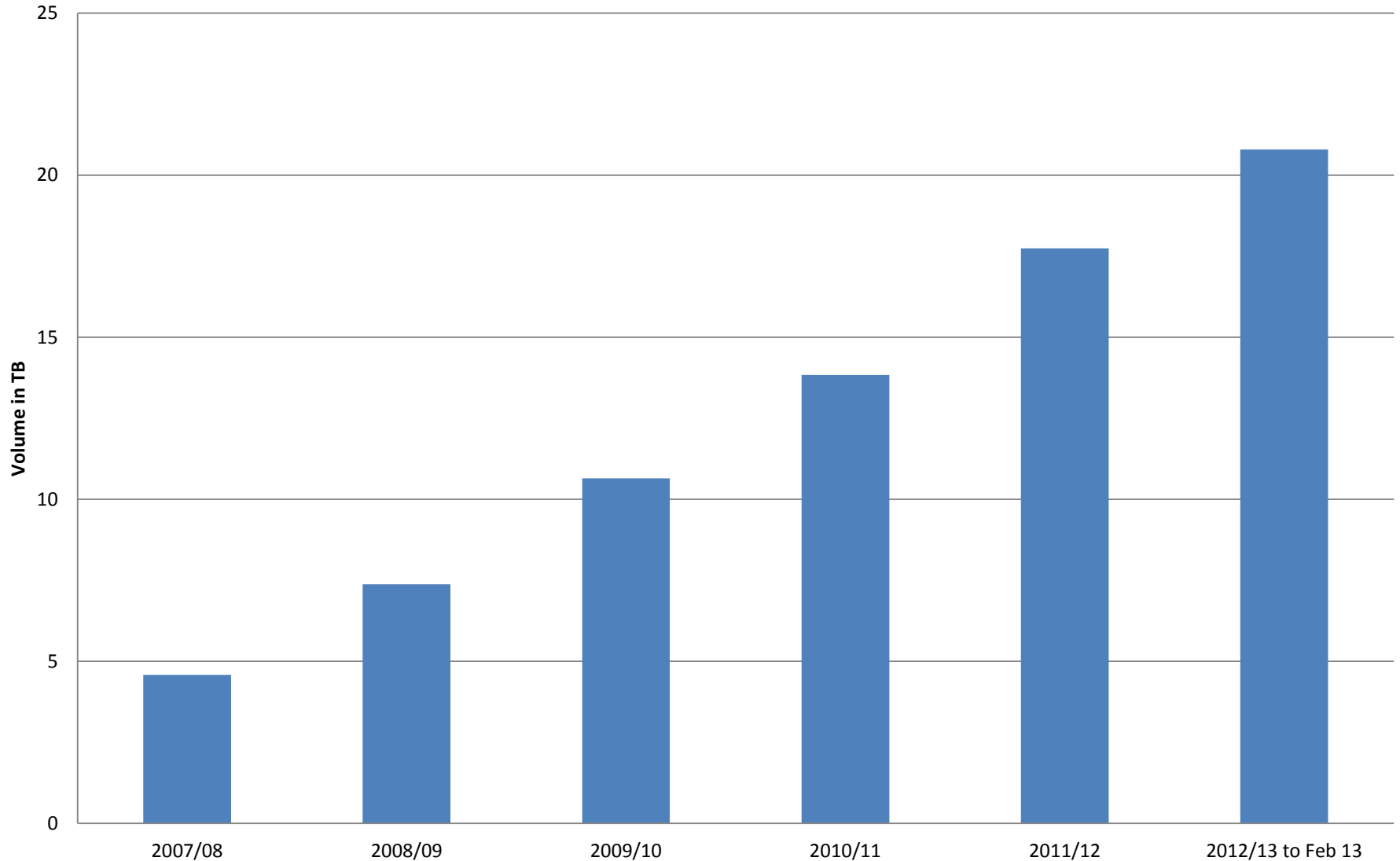

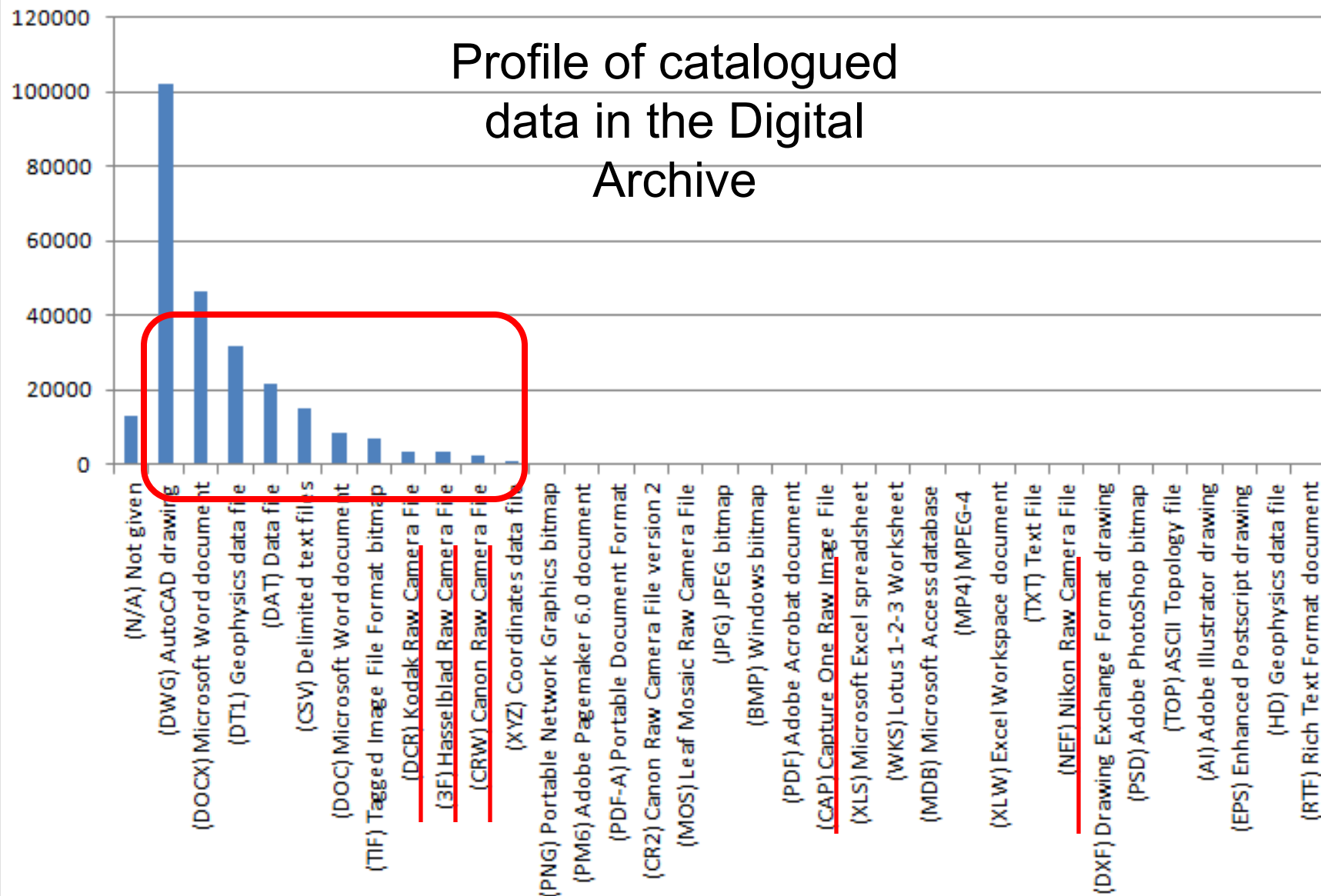

Growth of data (in TB) in the digital Archive



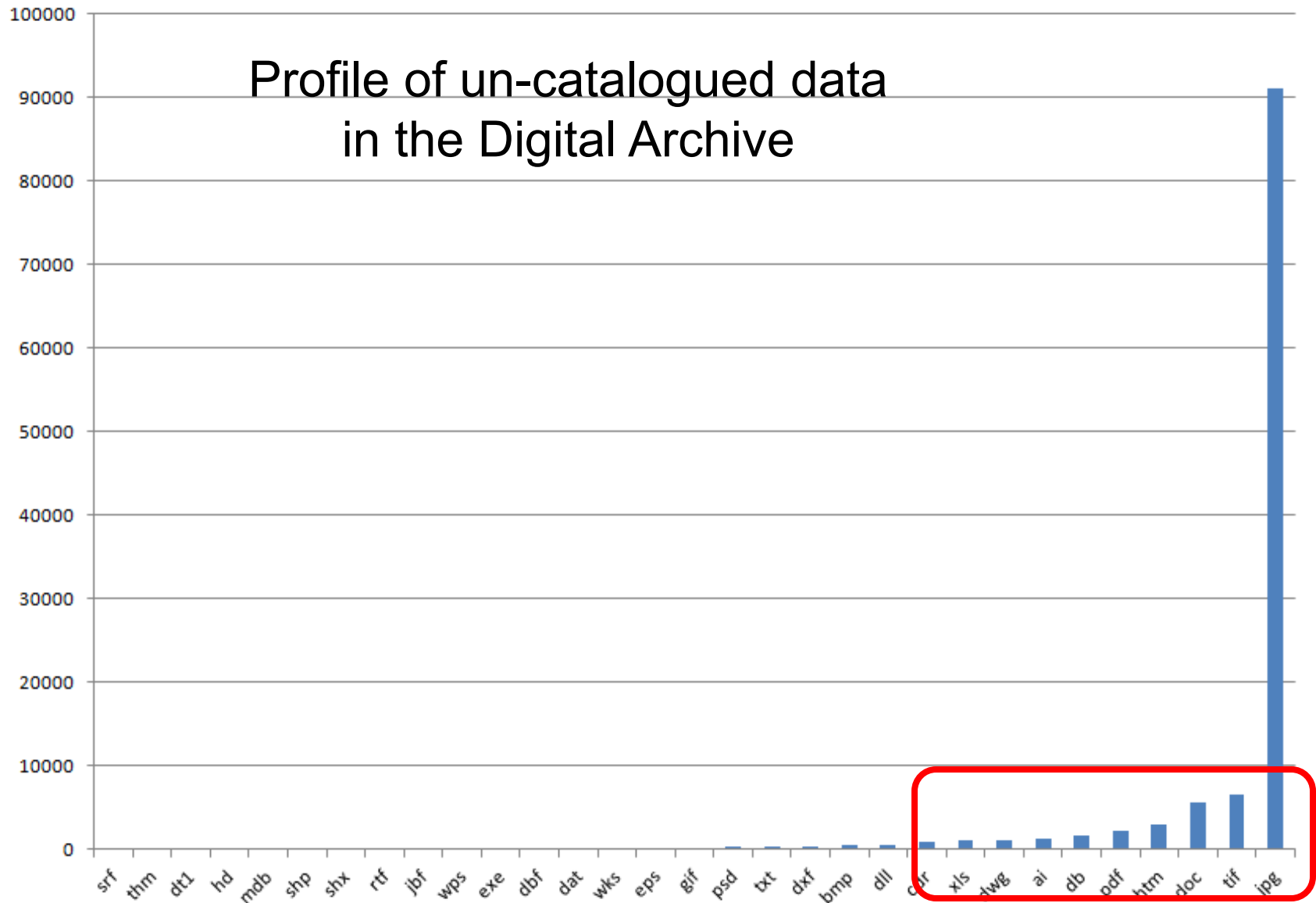
Types of material in our archive

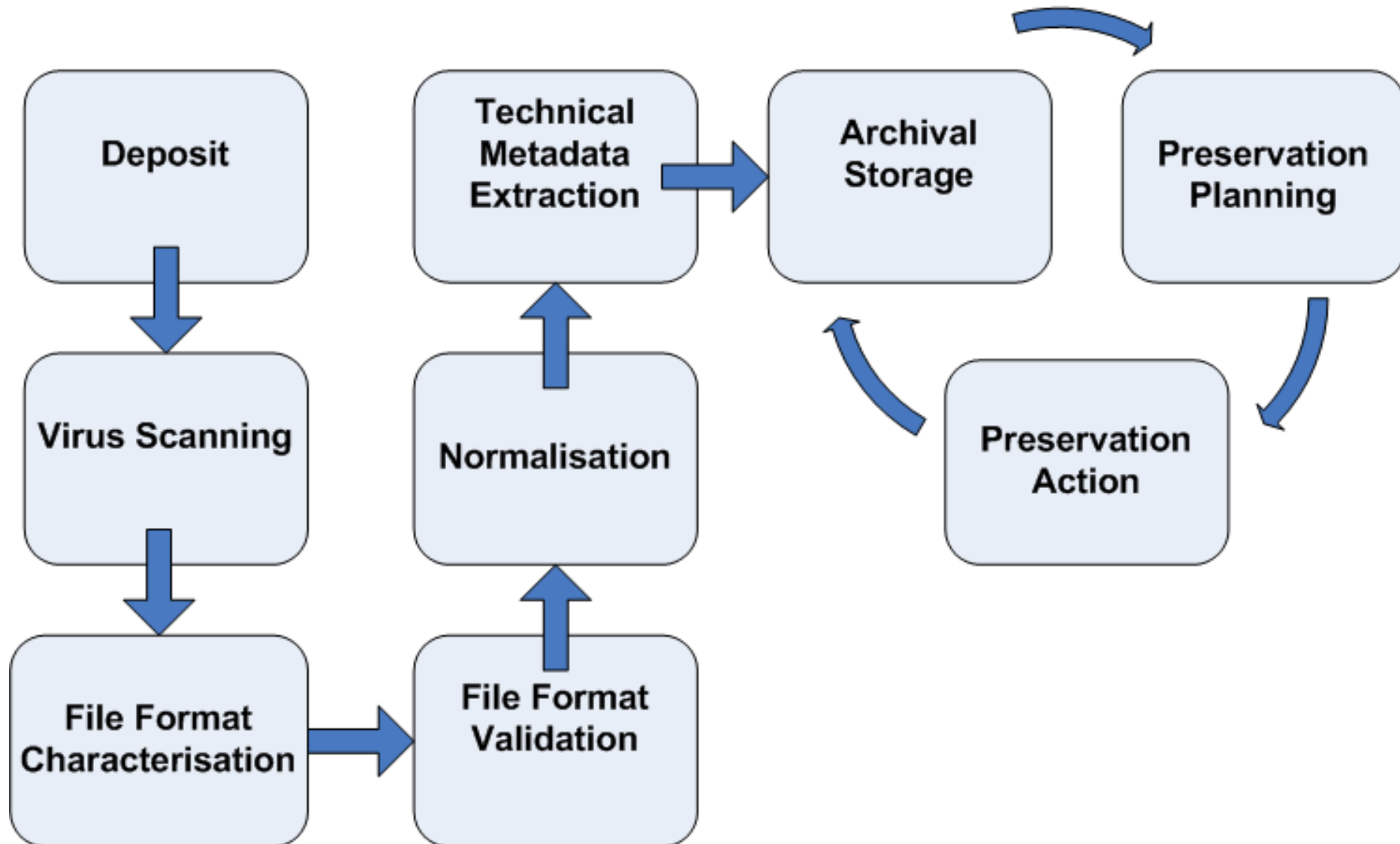

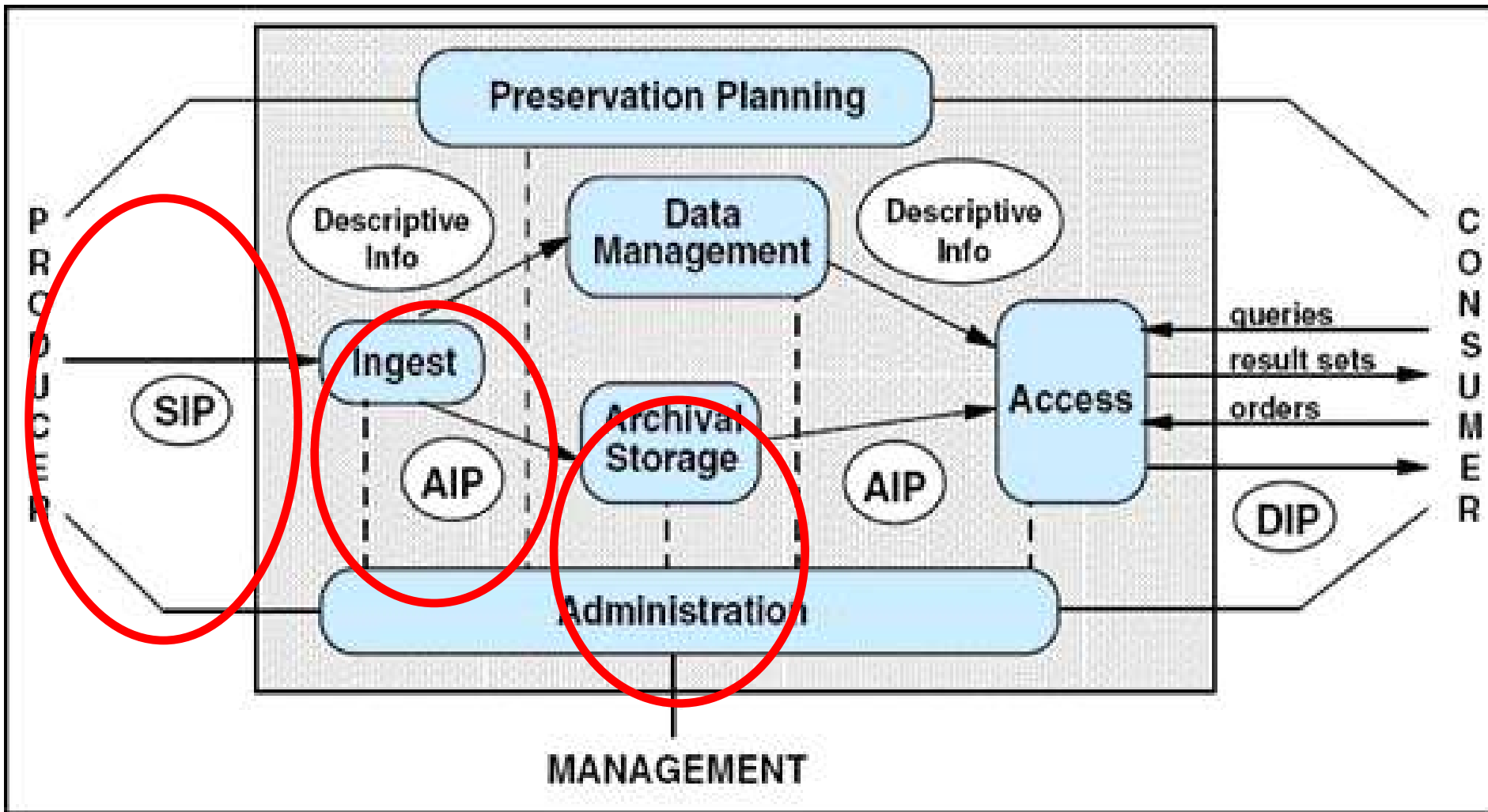

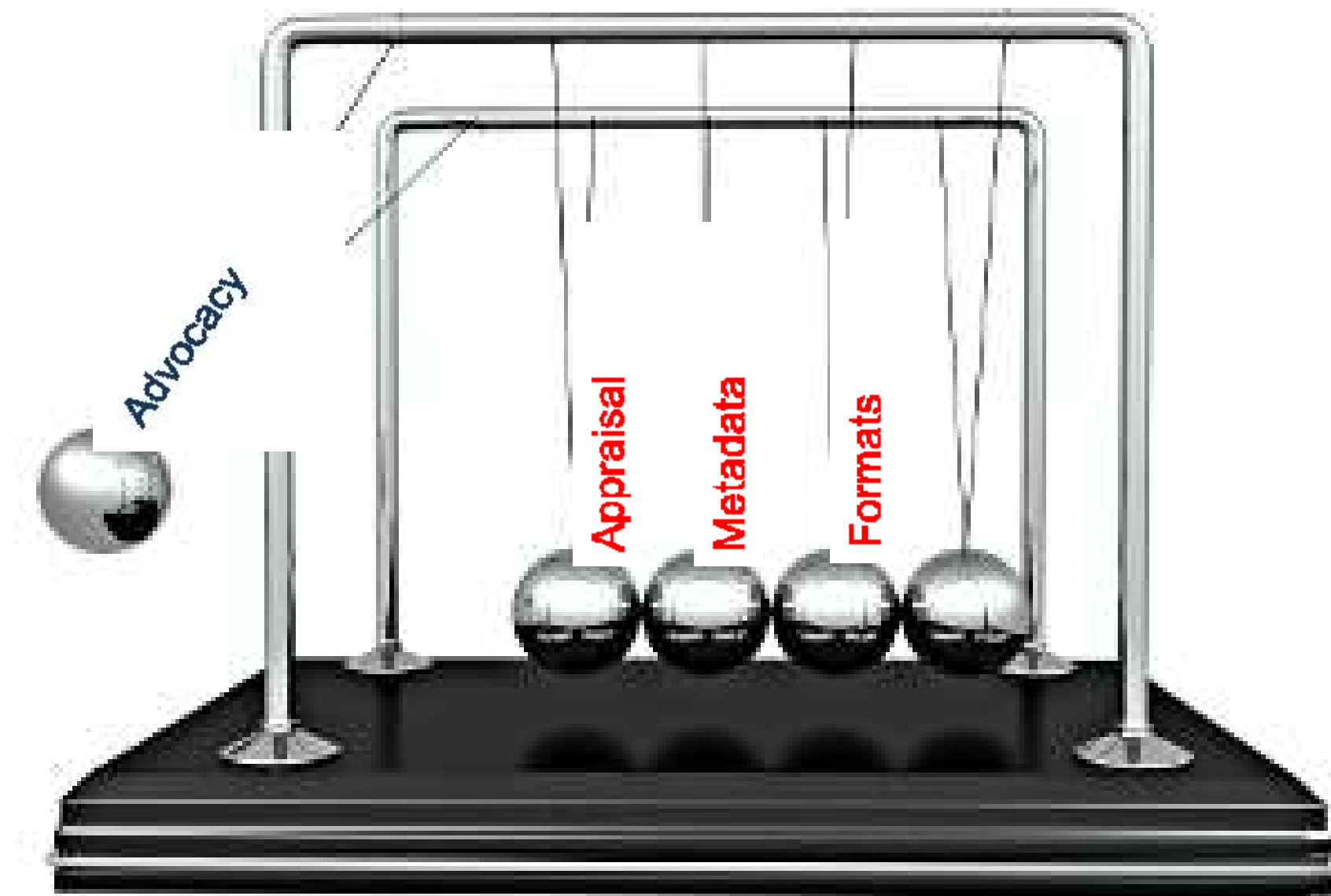
